Ladies and Gentlemen:

On February 9, 2009, pursuant Title 49, section 604.11 of the Code of Federal Regulations, the Indianapolis Public Transportation Corporation ("IPTC" or "IndyGo") submitted notification that it desired to provide charter service for an event of regional and national significance. Said charter service included providing shuttle service in passenger buses between three separate locations in Indianapolis, Indiana and one location in the town of Speedway, Indiana on Sunday, May 24, 2009 for the 93rd Running of the Indianapolis 500. Also pursuant Title 49, section 604.11 of the Code of Federal Regulations, several private transportation companies submitted written evidence of proof of being willing and able to provide service.

Additionally, IPTC filed a Petition for an Exception to Charter Service Regulations with the Federal Transit Administration for this service, which was denied. As such, IPTC withdraws its intention to provide this service.
