ATTENTION PASSENGERS OF ROUTES 39, 45, 46 AND 47

39 - Timmerman Flyer

45 - Watertown Plank Flyer

47 - S. 27th Street-Holt Flyer

46 - Loomis Southridge Flyer

Effective Sunday, January 3, 2011 there will be several changes regarding service. Three Freeway Flyer routes will be eliminated, two Freeway Flyer routes will be adjusted to serve other park-ride lots and 13 regular routes will have reduced service on Saturday. Changes are as follows:

Route 79 (Menomonee Falls Flyer) will now make a stop at **Watertown Plank Park-Ride Lot**

Route 46 (Southridge-Loomis Flyer) will detour due to construction and during that time it will stop at the **Holt Park-Ride Lot** for limited select trips. Roughly half the trips will serve Southridge, Loomis and Holt while the others will serve only Southridge and Loomis. At this point, this change is not permanent and will be reviewed once the construction is completed.

Three Routes will be eliminated: Route 39 (Timmerman Flyer) **Route 45** (Watertown Plank Flyer) and **Route 47** (S. 27th St. Flyer).

Additionally, Saturday service on thirteen routes will be reduced to Sunday level service. Those routes are **10, 11, 12, 14, 31, 33, 35, 51, 53, 54, 57, 67** and **80**.

For those who normally ride the eliminated Flyer routes we suggest these alternative routes although, there are also other routes in the area that may suit a rider's travel needs better:

Route 39: Routes 12, 23, 57 or 80

Route 45: Routes 10, 31, 44 or 79 (Route 79 has added a new stop at **Watertown Plank Park-Ride Lot**)

Route 47: Routes 11, 15, 19, 80 and 46 (Route 46 has added a new stop at **Holt Park-Ride Lot** for limited trips during construction detour)

New schedules reflecting these changes will have an effective date of January 2, 2011 and will be available online by Friday December 24, 2010 and on board buses starting Wednesday, December 29, 2010.
