#### A Message to the Dedicated Transit Advocate,

This is a projection of the service changes that would have taken effect on Sunday January 1st, 2012 had the Milwaukee County Transit System not received the Congestion Mitigation & Air Quality Funding (CMAQ) Grants to create the New MetroEXpress service, along with several route adjustments that went into revenue service on Sunday January 29th, 2012 in compliance with the Congestion Mitigation & Air Quality Funding (CMAQ) 2012 fiscal budget year.

I appreciate all the support from local transit advocates that are aware of the undying state of transit services provided by Milwaukee County throughout the past decade, which has endured either service cuts, fare increases or both during the implementation of fiscal year budgets presented to residence. I am ecstatic that there have been other local transit advocates that have voiced their opinion on transit issues that impact many commuters and that discussions were handled in a respectful manner.

I would like to personally thank all the followers that have supported the cause of transit issues presented through Chicagobus.org Forums under the discussion topic "MCTS: Service Disruptions and Uncertain Future". I would like to extend a special thanks to the Chicagobus.org Transit Forums administrator Kevin Zolkiewicz for giving Milwaukee transit advocates an outlet on transit issues that are a concern to us and for using this platform to allow other transit advocates from the Metro Chicago area and across the country to have knowledge about the transit issues we face in Milwaukee. It was great to see users that would use the forum to observe what would develop throughout the 2012 budget process. I am also glad that politics wasn't used as a ploy for users to discuss their political objectives as this discussion was about the concerned state of transit issues

Overall, the headline of the forum discussion might have not been receptive with some users, but it was a topic of discussion that wasn't just for transit commuters in Milwaukee, but in major cities across the country. Transit agencies have had to face drastic service reductions, fare increases or both in some fiscal budget years because of the lack of either local, state or federal dollars being presented to provide reliable transportation. There has been transit referendums created in government institutions that created separate legislation on how to fund, operate and provide transit services to communities. Some of these referendums have passed and others have failed, but the dedicated input by transit advocates have remained strong as advocates continue to strive for transit agencies that are integrated into providing economic growth within the local communities they serve. By updating or creating reliable infrastructure, transit agencies will continue to provide equal opportunities for every citizen within communities to have safe, reliable transportation options.

Listed below is a demonstration of what could have happened had local, state and federal officials not worked together to maintain transit services that are vital to the community. It has been a pleasure to share this experience with all the local transit advocates and Chicagobus.org forum users. I hope by reading MCTS Transit Budget | The Budget Crisis (2012 Budget Process), that readers understand that the decrease of transit infrastructure such as the one demonstrated has occurred since last decade to transit agencies across the country. Hopefully, local, state and federal officials continue to collectively join together on creating transit legislation that benefits commuter's mobility to travel to destinations that are vital to a community's economic growth.

The Milwaukee County Transit System will introduce service cuts to maintain the majority of the current service levels as State funding will be reduced by 10% in 2012 and 2013. Elimination of Four School Routes (Beginning Fall 2012), Six Regular Freeway Flyer Routes, MCTS Summer Festival Service provided by Shuttles and Extended Freeway Flyers Shuttles, Local Route Restructures and Realignments, the Introduction of Nine New Local Routes and Some Fare Increases are to take effect for the fiscal 2012 Budget Year as of Sunday January 1st, 2012. Detail information about service changes are listed below.

### Our overall methodology for making necessary changes includes

- Maintain access to job corridors and public service. We want to get people to their jobs
  - Minimize loss of service to transit dependent areas
    - Consider availability of alternate service
      - Simplify routes where possible
    - Increase overall efficiency of service provided
  - Minimal elimination of service on lowest producing routes or segments
    - Reduce service frequency on low producing route

The change in services will begin on Sunday, January 1st, 2012. Schedules will be available for preview on RideMCTS.com by Thursday December 15th, 2011. Printed schedules will be placed on buses, in information racks and sent to libraries and other locations by Wednesday December 28th, 2011. Also, look for a special edition of Buslines detailing all service adjustments in December 2011.

#### MCTS Fares Increases: Effective Sunday January 1st, 2012

Regular Adult Fare will increase 25 cents to from \$2.25 to \$2.50. Premium Fares will be maintained for Routes **79** (Menomonee Falls Flyer) (Plus the 25 cent Waukesha Zone Fare) and **143** (Ozaukee County Express) Transit Plus Fares will increase 75 cents from \$3.25 to \$4.00. The Commuter Value Pass will increase from \$195 per quarter to \$201.

#### Freeway Flyer Service Eliminated: Effective Monday January 2nd, 2012

Route **79** (Menomonee Falls Flyer), Route **143** (Ozaukee County Express) and **UBUS Service will be maintained and are not affected.** Routes **40** (Ryan/College Flyer) **43** (Whitnall Flyer), **44** (Fair Park-National Flyer), **46** (Loomis-Southridge Flyer), **48** (South Shore Flyer) and **49** (Brown Deer-Northshore Flyer) will be eliminated. **Last Day for service on Freeway Flyer Routes is Friday December <b>30th**, **2011**.

#### **Summer Festival Service Eliminated: Effective June 2012**

Summer Festival Shuttle to Lakefront Festivals along Wisconsin Avenue, Route **90** (Miller Park) and Summer **Freeway Flyer** Service to Summerfest, State Fair and Select Lakefront Events will be eliminated.

#### **School Routes Eliminated**

#### Beginning Fall Semester 2012, The following school routes will be eliminated

50 (Morgan Avenue), 85 (Whitman-West), 87 (Nathan Hale), 88 (Cudahy), 89 (St. Francis).

#### Local Routes Restructured: Effective Sunday January 1st, 2012

Over 21 Routes will be restructured and some segments along some routes will be eliminated. Most service areas will be maintained, but with frequency reductions, especially on the restructured routes. As a result, 9 New Local routes will be introduced to accommodate the loss of some service areas and to maintain service in other areas. Due to the number of bus stops changing, we will be unable to put up temporary signs at bus stops that are being replaced by another route.
