UBUS Fall Semester Service for Routes 40U, 42U, 44U & 49U

Route 42U (6th St-Port Washington Rd) service begins Thursday August 23, 2012.  
Route 40U (Holt/College UBUS) EXAM schedule will operate between Thursday August 23, 2012 through Friday August 31, 2012. Route 40U REGULAR schedule, Route 44U (Fair Park-Whitnall) & 49U (Brown Deer UBUS) will begin on Tuesday September 4, 2012

### Wisconsin Avenue Re-Opens Thursday August 9th, 2012

### Route 51 Extended Service & Route 137 Name Change Effective August 26th, 2012

Beginning August 26, a six-month trial program will extend service on Route 51 (Oklahoma Avenue) to better serve the Marian Center for Nonprofits located at 3195 S. Superior Street. Buses will be extended from Oklahoma Avenue and Superior Street to the Marian Center for Nonprofits. Two weekday trips will continue to serve the Archbishop Cousins Center at 3501 S. Lake Drive. Beginning August 26 Route 137 Route Name will be changed from "House of Corrections" to "County Correction Facility South"
